# MoU with Rotary Club, Meerut

## MEMORANDUM OF UNDERSTANDING

This MOU is made on 1 June, 2022 between Rotary Club Meerut, Club ID 15358, Rotary District 3100 through its duly authorized representative President Rotary Club Meerut of the first party and Ismail National Mahila (P.G.) College, Meerut, U.P. affiliated to C.C. University, Meerut through its duly authorized Representative Principal Ismail National Mahila (P.G.) College, Meerut of the second party. "Rotary Club Meerut" and "Ismail National Mahila (P.G.) College" are referred to as "Parties" collectively.

Both the parties have entered into this MOU with an objective to impart training to girls/women on sewing and designing skills in order to make them self-reliant by developing their skills and thereby enabling them to be self-employed and enhancing their value in society and generate household income through their own initiative.

### GUIDELINES

1. Ismail National (P.G.) College will provide empty space/room measuring not less than 300 sq. ft. which will be solely used for running the center.
2. Rotary Club Meerut will provide the basic cutting accessories/iron, furniture to the centre.
3. Rotary Club Meerut will put up banners in/around the school to create awareness about the sewing school.
4. The skill center has been set up in Ismail National Mahila (P.G.) College with 25 Machines made available by RCM which include
  - (a) Industrial Sewing Machine 14120ECA 1 Pcs
  - (b) Fashion Maker 4 Pcs  
FM-3229  
Simple Motorized
  - (c) Singer Tailor Delux 10 Pcs  
Foot with sheet metal

- (d) Merit Craftman Foot Basic with sheet Metal Stand

As these Machines are part of the training course.

5. There will be 2 types of courses :

(a) Certificate Course for 3 months

(b) Diploma Course for 6 months.

6. Both the courses will be available in batches throughout the year. Ismail Girls

College has to do is to enroll and fill up the admission form.

7. Standard curriculum for conducting Certificate and Diploma Courses will be provided by the Singer.

8. Singer will award Certificate/Diploma to successful candidates on completion of the course.

9. Trained Instructress who will teach and administer the class will be provided by the Singer. Her salary will be decided and borne by the Singer.

10. Singer. Instructress will collect admission fees for the Certificate/Diplome @ Rs. 100/- p.m. for each student and examination fees of Rs. 200/- and send to Singer

HO Marketing Department along with the list of students.

11. Representative of Rotary Club Meerut and Singer Supervisor will monitor the school and conduct examination for both the courses.

12. Rotary Club Meerut will call Singer technician to provide support for servicing of the Machines.

13. Ismail National Mahila (P.G.) College will bear the electricity, water and maintenance charges of the center including machines. The required material such as cloth, yarn, thread needles of machine etc. Will be provided by the Ismail Girls College.

14. Ismail National Mahila (P.G.) College will provide a SPOC (single point of contact) to Rotary Club Meerut and Singer.
15. Ownership of the Machines will be with Rotary Club Meerut. In case the center fails to run properly and with full capacity, Rotary Club Meerut has the right to remove the center from the premises of Ismail National Mahila (P.G.) College.
16. Women/Girls from the age of 18 years onwards will be eligible to attend the course and make centre a successful project.
17. In case of any accident or mishap during the conduct of the course at the premises of Ismail national Mahila (P.G.) College while operating the Machine, Rotary Club Meerut will not be responsible for any loss or liability.
18. Ismail National Mahila (P.G.) College will be responsible for the security and safety of the students at the Centre.
19. The Centre shall be opened to students from 9.00 A.M. to 5.00 P.M. every day except Gazetted holidays.


